

The Grenada Economic Development District presents

“Grenada’s Corporate Citizen of the Year Award”

The award is designed to recognize local for profit companies (industrial and non-industrial) for its role in improving the local economy through job creation and private investment, personnel development, and above-and-beyond corporate social responsibility (CSR).

Nominees will be separated in two categories: Less than 100 employees and more than 100 employees. A company can self nominate or can be nominated by other members of the business community, non-profit entities, and the public. The Grenada Economic Development District will notify nominees in the month of August and the winner will be announced at the EDD annual meeting in October of 2012.

Nominations will be accepted from July 1 to August 10 of 2012. A 7-member committee integrated by representatives of the business, non-profit, educational, and economic development sectors will select the winner which will be announced at the Grenada Economic Development District annual meeting in October of 2012.

Grenada Corporate Citizen of the Year Award Winner Criteria:

- **Job Growth & Private Investment**
Increase in full time employees and private investment in the last 3 years.
- **Human Resources Best Practices**
Programs or methodologies implemented in the business that differentiate the way they support the professional development and overall well being of their employees.
- **Community Support & Charitable Activities**
Programs or policies implemented by the business to encourage community involvement by their employees (including management) and the charitable donations (in cash or in-kind) presented to local non-profit organizations in the last 3 years to support the community well being of Grenada and its citizens.
